

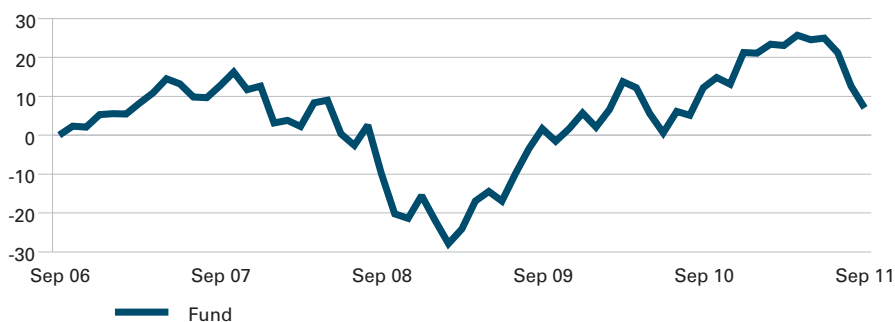

The investment objective of the Fund is to provide diversified exposure to UK and overseas equity markets. The Fund will invest 60% in the UK and 40% overseas. The Fund's overseas asset distribution is fixed with 14% in North America, 14% in Europe (ex-UK), 7% in Japan and 5% in Asia Pacific (ex-Japan).

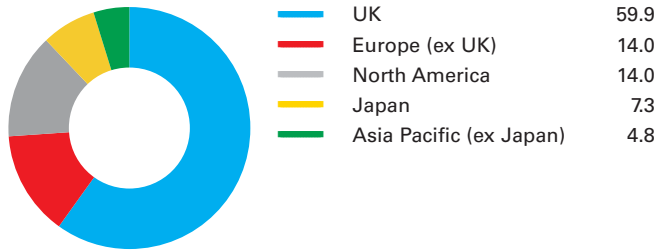
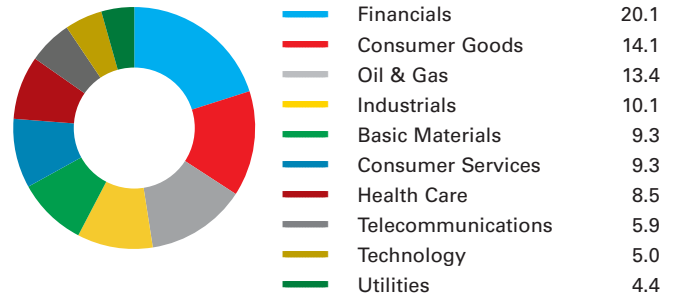

- The Index Fund Management team comprises 14 fund managers, supported by two Fund Management Assistants. Management oversight is provided by the Director of Index Fund Management and the Managing Director, Index Funds.
- The team has average industry experience of 13 years, of which 8 years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.
- The allocation for the Fund of Funds (FoF) is managed by Index Funds' Asset Allocation team. Management oversight is provided by Head of Asset Allocation and the Managing Director, Index Funds. The team of 7 Portfolio Managers has an average industry experience of 9 years, of which 4 years has been at LGIM.
